# 1. GENERAL INFORMATION ABOUT VIS

---

## 1.1 VIS AT GLANCE

VIS - *Volontariato Internazionale per lo Sviluppo (International Voluntary Service for Development)* is an association recognized established in 1986, a nongovernmental organization enrolled in the Civil Society Organisations (CSOs) register of the Italian Agency for Cooperation and Development (AICS), an “ONLUS” (no profit organisation under Italian law) enrolled in the register of non-profit organizations (Onlus) of the Direzione Regionale del Lazio of the Revenue Agency and is in the process of registering in the Registro Unico of the Third Sector, as soon as this will become operative in the section “Altri enti del terzo settore”.

VIS is engaged in development cooperation and international solidarity inspired by the charisma of San Giovanni Bosco; an educational agency promoting and organizing awareness raising, education, training for development and global citizenship activities: it implements a consistent advocacy networking with other stakeholders to impact on those identified as *decision maker* and Foster a medium and long-range social change.

VIS holds special Consultative Status at the United Nations Economic and Social Council (ECOSOC) and is accredited by ECHO- Directorate-General for European Civil Protection and Humanitarian Aid Operations of the European Commission (*partnership* renewed in 2020 following an *ex-ante assessment* obtaining the *Certificate EU HUMANITARIAN PARTNERSHIP 2021-2027*).

VIS operates in Europe, Africa, Latin America, Middle East.

“Insieme, per un mondo possibile” indicates the intention of networking in Italy, in Europe and the rest of the world to improve the living conditions of girls, boys, young people in vulnerable situation and their communities, believing that the causes of extreme poverty can be tackled at their root through education and training.

## 1.2 VALUES AND PURPOSE

**VISION - “A world where every person can fully enjoy their rights and participate with dignity and actively in the life of the community, promoting its development”.**

The Christian anthropological vision expressed in the social doctrine of the Church is combined, on the one hand, with the vision of the human being as a rights holder, anticipated in many ways by San Giovanni Bosco and expressed at international level in the conventions of the United Nations and, by 'other, with Amartya Sen's, the Nobel Prize for Economics, vision of human development, where development is "of the people, through people and for people": a development that is such only if it is integral, universal and sustainable in the social, economic, political and environmental sense, as set by the Sustainable Development Goals (SDGs) of the United Nations 2030 Agenda

In our vision of development there are both *empowerment* and *ownership*<sup>2</sup> on behalf of those for whom and with whom we work.

Vision and fundamental values inspiring VIS action have brought the organization to adopt a methodological approach towards broadening the individual and social capabilities with the double perspective of contributing to building and strengthening *rights-holders* 'capacities to claim for their human rights enjoyment (*capacities for empowerment*), as well as the capabilities of the corresponding *duty bearers* in the fulfilment of their duties (*capacities for accountability*).

**MISSION - "Foster the development and broadening of each person 's capacities of - as individual and member of a community - paying particular attention to the most disadvantaged and vulnerable girls, boys and young people, providing them with educational, training, and social-vocational insertion opportunities, as well as tools for the promotion and protection of their human rights".**

### 1.3 CONTEXT OF REFERENCE

2020 has been the year of SARS-CoV-2 pandemic, an event that has characterized every area of living in Italy and around the world and which, at the date of drafting this Activities Summary Report, has not yet ceased its consequences. In this sense, what happened in 2020 will not only maintain its effects in the following years but, as noted by various analysts, will impose substantial and strategic changes in social and economic policies, in the approaches and methodologies adopted in different fields of human knowledge and , as regards the identity and focus of VIS action, also in international relations, development cooperation policies, national and trans-national human mobility as well as on the various conditions and perspectives of its target groups.

By their very nature, the poorest and developing countries are particularly vulnerable to shocks and, therefore, the pandemic has had and is producing extremely high impacts not only from a health and humanitarian point of view, but also from a social and economic point of view. Low levels of economic growth and high inequalities, lack of internal financial resources, high levels of debt and the fragility of health systems are the most pressing challenges. But what emerged immediately as a health crisis has already had far-reaching consequences on education, human rights, food security and economic development in the medium and long term, as well as on the continuation and outbreak of new internal and regional conflicts. As the pandemic impacts are emerging and advanced economies herald expansive and large-scale economic interventions and strengthening national health systems, it is imperative that the international community does not neglect the responsibility of supporting vulnerable countries with an integrated approach on at least two guidelines:

- provide useful resources to stop the spread of Covid-19, rapidly develop resilience and capacity to curb the epidemic and to alleviate its effects;
- take action to avoid economic collapse and restore economic growth basic conditions.

During 2020, immediately after the pandemic outbreak, in line with the appeal made by Pope Francis to the entire Church, the Salesian world has also launched many initiatives in most of the countries of the world where Don Bosco's establishments are present: distribution of food and basic necessities, hygienic-sanitary support, water supply, realization and distribution of safety devices, remote education and pastoral support, making available centers and structures for assistance and shelter activities managed by the local institutions, etc. The collaboration established with the governmental structures of various countries, companies, associations, NGOs, and community organizations have allowed the Salesian Family to respond immediately to the basic needs of the most vulnerable people, and VIS has not pulled back (as can be seen from the following in-depth information sheets).

The worldwide commitment of the Salesian Family to counter the consequences of the pandemic has been and will constitute in the long run for our NGO the fundamental reference framework for developing the meaning and impact of its humanitarian and cooperation action in response to an emergency that has taken on dimensions and characteristics never known since the end of the Second World War. In this sense, while

focusing on the sectors and operational areas typical and prior for its mission, VIS has started and will increasingly develop the identification and preparation of integrated and articulated programs, to be implemented in the medium and long term, directed towards countering the dramatic socio-economic consequences of the pandemic for the poorest countries, the most vulnerable communities, and social groups.

Last year, the pandemic resulted in two different situations in terms of public and private donors' behaviours:

- programs financed by institutions, being supported by multi-year financial resources already allocated and contractually committed for their implementation, have not undergone cuts or postponements due to payments or disbursements being blocked. On the contrary, some donors (including AICS) have not only allowed the reshaping of operational schedules, a certain management flexibility and the adoption of specific measures to combat the spread of the pandemic but have also allocated additional funds for ongoing initiatives (for development and emergency) to cope with the higher costs incurred by the executing organizations and the reduction of resources from other donors destined for co-financing. On the other hand, at least in this phase, the definition of the projections for effective commitment in the next few years by the same institutional donors remains uncertain, given that the priority character in the political agendas, in the public expenditure and investments that interventions and development cooperation programs in poor countries will enjoy is not yet identifiable;
- resources donated by private donors for development cooperation and humanitarian aid have suffered a general decline due, on the one hand, to the economic crisis and the priority of addressing the national health and social emergency and, on the other hand, of the perpetuation of the consequences determined by the instrumental attacks on the NGO sector perpetrated in recent years. As can be seen from the balance sheet, these elements also characterized some segments of VIS fundraising in the previous year. The in-depth analysis - also in perspective - of the context which our organization must face, considering the global impact of the pandemic, forms the basis for the redefinition and elaboration of VIS Strategic Plan for the coming years. As terms of reference, in addition to the areas of critical importance (People, Planet, Prosperity, Peace and Partnership) identified by the 2030 Agenda and its 17 Sustainable Development Goals (SDGs), it will have to consider the fundamental guidelines that the Magisterium of Pope Francis is producing on integral ecology, education, dignity of work and inalienable and inviolable rights of the person.

## 2. OBJECTIVES AND ACTIVITIES

---

### 2.1 PRIORITIES, OBJECTIVES AND RESULTS

VIS, in line with the 2018-2020 Strategic Plan<sup>3</sup> (SP 2018-20) approved by the Members Assembly of 04/11/2017, intends to achieve the objectives of its mission in an increasingly integrated and innovative way in the context of a world continuously changing. The main institutional purpose, which can be deduced from VIS Bylaws and confirmed in the annual program, remains the promotion of a human and sustainable development and the growth of each person's and community capacities, placing a particular focus on the most disadvantaged and vulnerable girls, boys, and young people.

On this point, it is noted that presently the revision of the Bylaws of the organization is being implemented, the text and original content of which date back to 1986 (year of VIS creation), in order to make it not only consistent with the terms and provisions established by the reform introduced by Legislative Decree 117/2017 (Third Sector Code), but also in line with the most recent standards and principles of development cooperation and international solidarity; the new Bylaws will undergo the approval of the Extraordinary VIS Members Assembly scheduled for 16/06/2021.

The SP 2018-20 illustrates the strategic objectives, the theme-sector priorities, and the fundamental feature of VIS action. The scope of the human and sustainable development is pursued setting some strategic objective (defined through a human rights-based vision) and operating primarily in the context of six areas / sectors:

1. education;
2. training and socio-professional integration;
3. strengthening of local CSO actors (first of all of our partners);
4. vulnerable child and youth protection;
5. programmatic enhancement of the link between migration and development;
6. environment safeguarding, as a cross-cutting theme of all VIS actions.

In addition, it considers functional to the programmatic action strengthening the institutional and operational synergy with the other Salesian solidarity actors in Italy (Missioni Don Bosco), develop the rooting of the organization in the national territory through the Presidia and the volunteer participants and the implementation of an organization structure and an improved management system in terms of accountability and effectiveness.

From a geographical point of view, the SP 2018-20 confirms the trend of concentrating interventions characterizing VIS action in the last 10 years, establishing some partner countries as priority, i.e. Where to invest with programs financed by the main institutional donors, country offices with expatriate staff and develop specific programme strategies.

It should be noted that the multi-year SP will also undergo re-elaboration and approval during 2021 and become effective in its new version starting from 01/01/2022.

The 2020 operational and financial programme has confirmed the thematic-sectorial priorities identified by the SP 2018-20, requiring the increase above all of integrated interventions aimed at preventing undocumented migration and the local development, the use of innovative tools and methods to make financial, technical and know-how resources accessible for the target groups, as well as strengthening psycho-social protection and support actions for girls and boys and for the most vulnerable communities. Regarding emergency interventions, based as usual on an LRRD approach, the 2020 programme considered as a priority the areas of Western and Eastern Africa and Palestine, in which to conduct livelihood support actions, strengthening of resilience and educational activities in emergency contexts, as well as activities to support refugee communities and to prevent undocumented migration.

The spread of the Covid-19 pandemic worldwide and its consequences on the health and socio-economic level, as well as on international and national mobility, did not lead to substantial changes in the objectives and planned priority actions, but caused a redefinition of their implementation timing (with a generalized

lengthening) and of the implementation methodologies (with widespread smart working, reduction of events and activities in presence, etc.), as well as the integration in the planned programs of specific activities aimed at prevention and containment of contagion risks and mitigation of socio-economic effects on the most vulnerable groups. Different, as will be specified below, has been the evolution of institutional activities in Italy, which have instead been strongly affected by the general lockdown and which have been reprogrammed and redefined compared to what had been previously estimated.

**In partner countries**, the final balance of activities implemented in 2020 is, net of the specific actions to fight the pandemic, in line not only with the Bylaws purposes and activities, but also with those predefined by the SP 2018-20 and Annual Program. This is evident above all because the initiatives implemented during the year and those presented and approved by the main public and private donors reflect guidelines, objectives and expected results. Leaving the in-depth analysis of the specific records below listed, it appears here appropriate to highlight:

- consolidation and development of project actions linked to the theme migration-development in Ethiopia, Eritrea, Senegal, Gambia, Ghana, Mali and Nigeria;
- introduction and implementation in Ghana and Senegal of the project design expertise already gained over the years in Albania through the establishment and operation of development funds for both individual and community employment/assets;
- continuation of development projects in Palestine and Albania with a specific focus on local socio-economic development, also in rural and marginal areas;
- development of psycho-social protection and support both for girls and boys in Angola and Palestine, and for vulnerable groups and communities in Ethiopia and Eritrea.

The most significant changes to the operational strategies envisaged in the program and performed in 2020 certainly concerned the remedial activities and the project remodelling in an anti-pandemic key and, from last 4th November, the total holdup of activities in Tigray (Ethiopia) due to of the outbreak of the conflict between regional forces and the federal government, with the resulting launch of the connected emergency still in progress.

The gradual downsizing of VIS presence and commitment has continued in Bolivia and Haiti, countries initially considered priorities for VIS, and where activities will be concluded by 2021.

VIS presence and engagement in Syria and Lebanon have still not started, due to delays and the strategic action features so far assumed by the the local partners (the Salesians of the Middle East Province), as well as program synergy difficulties with Don Bosco Tech Africa, the Salesian organization for the continental coordination of vocational training. Also, follow-up and development activities of the PDO strengthening program in Africa and Latin America have not yet been started due to the pandemic and lack of endorsement *ab origine* on behalf of the Salesian Congregation.

The summary is presented below, followed by the countries, divided by geographical areas, in which the VIS was active with development projects in 2020.

**In Italy**, the year 2020 has been particular because of the pandemic which has above all upset the working methods and intensity (with the adoption of smart working and the FIS. Despite this, the three main objectives for activities in Italy had been set, these were achieved, thanks to the capability to quickly convert and adapt the main project activities to the new situation.

The 2020 goals for the Area Italy can be summarized in three key words: innovation, education, visibility. With reference to innovation, the main activities concerned the web platform for online training and VIS institutional website. The renewal of the e-learning platform has made it possible not only to create a more comfortable and functional virtual environment for the student's community, but also to renew the teaching methodologies, increasingly favouring the participation and collaboration components of the courses. The new VIS institutional website has been redesigned by rethinking the navigation and the graphical interface (so-called User Experience - UX) to enhance the activities in the field and bring internet users closer to the stories of the on-site beneficiaries. Contents such as "Stories from the field" and "News", which describe experiences from the countries, have found a new narrative path, the navigation of content aimed at cooperation professionals as well as has been improved by integrating a vacancies section with the training one. All this has allowed greater interaction with customers and users of the site.

With respect to education, during 2020 VIS had to change its operational strategies, due to the pandemic. The attention was almost exclusively addressed to primary school students forced to stay at home and teachers to support them in the new experience of distance learning, through the launch of the resto@ttivo campaign, which allowed the school to have more tools to face the difficult moment

With reference to the third keyword, visibility, communication initiatives were mainly focused on VIS response to the pandemic in Italy and partner countries, a strategy that has also contributed to the growth of the organization positioning.

Finally, the three guidelines found a substantial synthesis in the implementation of the program to fight pandemic consequences in Italy, financed through the NGO Salesian Missions of New Rochelle by the U.S. Agency for International Development (USAID), of which a detailed presentation is bellow illustrated.

## VIS IN ANGOLA: MAIN INTERVENTIONS IMPLEMENTED

In 2009 VIS together with the Salesians launched the program "*La Strada per la Vita*" with the aim of recovery, support and social and family reintegration of children, adolescents, and young people in street situation and/or most vulnerable in Luanda. In 2020 the 3rd phase of the program was continued thanks to the project "*Vamos Juntos*", co-financed by the EC, including capacity building actions for local institutions and civil society organizations (CSOs), promoting dialogue, participation, and inclusion of Angolan CSOs and rights holders in national policies and programs for the protection of children in street situation.

The project is carried out in partnership with the Salesians of Don Bosco, the Institute of Religious Studies in Angola and the NGO SamuSocial International and foresees the involvement of 28 associated realities. A special attention is given to girls in street situation a highly innovative action for VIS and the Salesian counterpart.

In 2020 a project was launched for the active participation of young people in the country development with the project "*O Futuro nas Nossas Mãos: nós jovens protagonistas do desenvolvimento de Angola*", co-funded by the EC. Direct partners of the project are the Salesians of Don Bosco and the Institute of Religious Sciences

as well as 22 associated realities, including 3 youth associations. The project will be carried out in Luanda and in 4 other provinces in the country.

In response to the Covid-19 emergency, the project "*Todos para Todos*" was launched, co-funded by the EC in collaboration with the Salesians of Don Bosco, to mitigate the effects of the pandemic within the most vulnerable and exposed communities.

### Main intervention implemented in 2020

- continuation of technical assistance to high-level Angolan institutions by strengthening the advocacy mechanisms and the exchange of best practices, which involved the State Secretary of MASFAMU and the National Direction of INAC;
- launch of new community child protection actions in response to Covid pandemic, the main target of which have been children in a situation of malnutrition;
- implementation of protective and preventive actions and services for children in street situations during the lockdown;
- alignment of the criteria for assessing the vulnerability of households for the disbursement of the family grants of the CGFAF;
- continuation of technical support for *Casa Anuarite* for the reception of former children in street situation;
- start-up of technical support collaborations with reference social actors e.g. the national NGO ADRA for networking activities;
- implementation, in the training and institutional spaces activated, of awareness-raising and training actions in line with the UN GC no. 21 concerning children in street situation;
- strengthening of the media and web VIS projects visibility also through high-level visits (head of the European Union Delegation of Luanda);
- communication activities on the web site through news and a social campaign which had a coverage of 5,270 visitors on Facebook with 258 interactions.

The conditions due to the pandemic, which particularly limited the start-up of the project on youth participation, the reduced presence of expatriate personnel and the lack of openness on behalf of the

Salesians of Don Bosco for the methodological accompaniment to the *Casa Anuarite* were among the factors that hindered the effectiveness of the actions.

**Interventions in response to Covid emergency:**

- within the project “*Vamos Juntos*” the activities of the street multidisciplinary team have been reoriented to support the protection of children in the first phase of their reintegration program through the creation of two shelter homes;
- 2 project proposals financed by CEI and World Vision for mitigating COVID effects in reception centers;
- 1 new project financed by the EU Delegation in Angola on prevention and mitigation of Covid effects on the communities and aid to mother-child healthcare;
- Staff awareness raising about anti Covid rules and regulations, providing them with prevention systems and products, dispensing at risk personnel, reducing the presence in the workplaces, and organizing shifts according to the rules foreseen *in loco*.

## VIS IN BURUNDI: MAIN INTERVENTIONS IMPLEMENTED

During 2020 there were changes aimed at promoting VIS placement in the country. In January 2020 VIS office was transferred to the Salesian center in Buterere, to optimize resources and allow greater collaboration with the Salesian school and, in general, a consolidation of VIS experience in the TVET sector.

A second shift concerns the intervention sector area. In fact, 2020 was also characterized by the launch of interventions in the health sector thanks to the partnership with the Museke Foundation. Since January 2020, two projects were started focusing on mother-child health care and cervical cancer prevention as a pilot intervention - the latter in collaboration with the local association Buraca. The first project aims at strengthening the capacity of 15 health centers located in Bujumbura rural suburbs in the field of mother-child health care, with particular attention to new-born and childcare, to reduce morbidity and mortality linked to diseases, more frequent in the 0-5 age group. The second intervention instead aims at contributing to the reduction of cervical cancer cases in the population of the Northern District of the Bujumbura Province by upgrading the skills of health workers. The intervention has a purely pilot character; in fact, the dissemination of the project outputs will serve to extend and possibly replicate the project, as well as to make the data known to the main donors and key players active in the country. Both interventions were started in the second half of 2020; however, only the preliminary and preparatory activities were carried out as the Ministry of Health delayed signing of both executive agreements.

Regarding the TVET sector, the project "*Bâtir l'avenir*", which ended in December 2019, has allowed VIS to become a key actor in this sector and during 2020 this experience has continued to be consolidated also through the development of a map of the TVET centers in the country, in preparation for the development of new interventions planned for 2021.

### Main interventions implemented in 2020:

- Identification and selection of partner health centers for the mother-child health care project located in Bujumbura Northern District, in collaboration with the local offices of the Ministry of Health. In parallel, through a careful analysis the following health center to be involved in the cervical cancer prevention and treatment initiative were identified: three decentralized health structures, a clinic and the public hospital of Bujumbura Northern Health District;
- defined the agreement with the local partner Buraca which will be the main actor involved in the cancer prevention project;
- continued thematic meetings with other NGOs and key players in the TVET sector to consolidate VIS position VIS in this area.

Weaknesses can be highlighted in the complex situation that involved VIS new registration phase in the country, uncertainty of available funds in the country and of the calls provided for by the most important donors together with the widespread political uncertainty, which has not allowed the implementation of medium-long term strategies.

### PROSPECTS 2021

Within this context, the possibility of involving as target the refugees in camps and/or local women's associations will also be evaluated.
- Strengthen the operative *partnership* with Fondazione Museke above all in the health sector.
- Consolidate the work of promoting VIS placement in the country especially in the TVET sector to capitalize on experience - a strategy that had to be already implemented during 2020, but which unfortunately suffered a severe slowdown mainly due to the deferral of many activities due to Covid-19 pandemic as well as to the security instability of the country.

## VIS IN RDC: MAIN INTERVENTIONS IMPLEMENTED

VIS is present in the DRC since 2003, almost only in the Eastern regions and in 2010 it has obtained the recognition from the Ministère du Plan as organization eligible to operate in the social domain. VIS works thanks to private funds and the institutional support funds provided by – MAECI and EU – and collaborates mainly with the Salesians of Don Bosco and many other local CSOs. In 2013 VIS has broadened its field of intervention also to Eastern Kasai, more precisely in Mbuji-Mayi, supporting the local Salesian community in the Center *Don Bosco Muetu*.

The year 2020 has been for VIS in DRC a difficult year, however, at the same time it has been crucial with respect to its orientation as VIS has decided not to follow emergencies but rather to continue along the path

of development, therefore, to propose interventions in such direction. In 2020 VIS recognition in North Kivu as credible and reliable actor collaborating with the *Centre des Jeunes Don Bosco Ngangi* CDBNG with its specific and clear functional and management independence has continued to be consolidated. The areas in which VIS added value has been mainly recognized have been vocational training- especially considering the work implemented with the girls of *Casa Mamma Margherita*, also through interventions connected with gender discrimination- and child protection in a context remaining a conflict one.

Nord Kivu- being the scene of wars, epidemics, and widespread insecurity – nowadays is still focused on emergency interventions, while the VIS-DRC is more focused on development projects: this for the first part of the year has created a slowdown in the project design activity.

- Operators of 15 health centers trained on prevention measures, management, and protection of medical staff in case of Covid-19 disease.

## VIS IN ERITREA: MAIN INTERVENTIONS IMPLEMENTED

During 2020 in Eritrea the joint planning with the Salesians started in 2018 has continued, after a long period of inactivity due to the socio-political conditions of the country. Although it is not yet possible to register as NGO, VIS has nevertheless managed to continue the planned activities, in particular the projects financed by the Swiss Agency for Development and Cooperation. In fact, in July 2020 the first support intervention for the Dekhmere school ended – however extended due to the Covid-19 pandemic which slowed down activities but made it impossible to send expat teachers for the courses (therefore this has been side-stepped by organizing pedagogical and non-technical courses employing local staff). Thanks to the consolidated partnership with the Swiss cooperation, a new three-year project began in October 2020 with a particular focus on updating the skills of teachers and teaching and non-teaching staff, to improve the quality of secondary vocational education. Furthermore, the collaboration with the only other Italian NGOs active in the country (Nexus, Prosud and Iscos), attached to the Eritrean trade union (NCEW), has been consolidated, with the prospect of a positive synergy between different skills: VIS more oriented towards " technical assistance focusing on adapting curricula to the skills required by the market and other NGOs more oriented towards job placement in the difficult context of the local labour market. Thanks to the collaboration, in 2020, in addition to starting the project "Dialogue, train, negotiate: work as a means of peace" (funded by AICS with NEXUS as lead partner), the project "Women's Councils: models, skills and voice for a just society in Eritrea", funded by the EU with Iscos as leader organization.

In addition, within the WASH sector, the project "Improving access to water and sanitation conditions in the village of Asetah, Eritrea" has continued in collaboration with the Acqua per la Vita Onlus association. During

2020, the well was excavated and the procedures for the purchase and dispatch of materials for its construction were completed – intervention to be completed in 2021, as activities were stopped due to the pandemic.

The main lines of action common to all projects in the training sector carried out in Eritrea are support for the definition of curricula in line with market needs, teacher training as lifelong learning, improvement of the quality of education through the supply of materials and equipment in line with the most advanced technology, organization of trainings for students and the start of school-to-work transition pilot courses, despite the static context of the Eritrean labour market.

VIS strength points in Eritrea are the operational partnerships both with the Salesians of Don Bosco and with the local association of the trade unions, which allow to carry out timely and highly relevant interventions to the real needs of the population, focused on training and the increase of job opportunities to improve the conditions of vulnerability in which most of the young people belonging to the age group in which the recipients of our interventions fall (15-29 years).

- Organization of Summer courses of trainers pedagogical and didactic training of the Salesian school at Dekemhare;
- Coordination of Italian NGOs active in Eritrea, partner of the local trade union;
- Well excavation and dispatch of all its construction materials part of the emergency project in WASH sector at the village of Asetah, near Dekhmere.

The country has a high degree of operational difficulty, regarding the operations of the local SDB partner due to the limitations imposed by the Government, and the impracticality of having formal recognition and therefore the presence of own operators, both local and expats. In addition, during 2020, it has been impossible to carry out a monitoring mission because of Covid-19 pandemic as the country closed its frontiers and the access to foreigners. Nevertheless, the *performance* was in general good, considering the limits deriving from the absence of VIS expat staff and the difficult communication (due to the lack of internet connections) – thanks to the good level of the local staff of the partner.



## VIS IN ETHIOPIA: MAIN INTERVENTIONS IMPLEMENTED

2020 has been characterized by was characterized by a consolidation of ongoing projects, which slowed down due to the Covid-19 pandemic. Despite this slowdown, most of the planned activities were carried out in the historical implementation areas of the interventions, namely Addis Ababa, Tigray, Gambella and Somali Region. In 2020, the SNNP (Southern Nations, Nationalities and People) region was added to these regions, where VIS has opened an office to better implement the "ENJOY" project funded by the EU as part of the Trust Fund Africa, led by Caritas Switzerland. Between Summer and September 2020, important development projects were completed, including the Trust Funds belonging to the SINCE program for the prevention of undocumented migration (one in Addis Ababa with PIN leader organization and one in Tigray with VIS leader organization), as well as an important emergency project funded by AICS and carried out in the refugee camps of Shire.

The commitment in the Gambella region also continued in favour of South Sudanese refugees and host communities, aimed at strengthening the socio-economic resilience of both categories, promoting greater integration between them.

From a thematic point of view, the main axis continues to be vocational training and job placement, as a measure to fight undocumented migration. At the base there is the re-evaluation of vocational training (meant as short courses in line with market needs, immediately expendable in the company or as self-employment) linked to job placement declined in a different way according to specific local characteristics: e.g. it can favour self-employment in rural contexts, rather than in company employment (through public/private partnerships) in urban contexts.

In November 2020, a conflict between regional forces and the central government broke out in Tigray, resulting in a high number of internally displaced persons and an increase in food insecurity, as well as a situation of chronic insecurity and a high level of vulnerability for the entire population, especially for the weakest groups, such as women and minors. VIS immediately engaged with the Salesian communities present in Tigray- thanks to the support of MDB in first place- to respond to the very first emergency, through food distributions that began at the end of 2020.

### Main interventions implemented in 2020:

- Inclusion in the labour market of potential migrants, return migrants and refugees in the regions of Tigray and Addis Abeba, through short trainings in line with the market and transition paths school/labour aimed at increasing the skills required by the companies and facilitating their employment. More specifically pilot innovative paths of *work-based learning* have been started with the aim of improving the cooperation between school and companies to increase the work opportunities of vulnerable youth;
- Establishment of urban cooperatives in the metallurgy and building sectors to favour the urban employment of the most vulnerable segments of the population;
- Promotion of sustainable and lasting public/private *partnerships* aimed at improving the local sector governance in the region of Tigray, to increase the dignified employment of youth and women particularly vulnerable;
- Implementation of decent job placement paths for vulnerable young people, through the establishment of cooperatives and individual income-generating activities;
- Improving the training offer in qualitative and quantitative terms of the technical Salesian and public schools, above all for what concerns the organization of short courses in line with the market and the administrative management of the institutes;
- Implementation for short training paths and sport and recreation activities for young refugees present in the refugee camp of Nguenyiel in the region of Gambella;
- Building of a center for extensive agriculture in Karmi, in favour of the hosting local community of the refugee center of Jewi, in the region of Gambella;
- Start of operations in the region SNNP through the implementation of the first assessment activities and the research connected with the project “ENJOY”.

It must be highlighted how working in emergency/conflict area where it is not possible to travel makes difficult monitoring of interventions. Due to the dimension of the ongoing interventions, it would be necessary to enhance coordination.

### Interventions in response to Covid emergency:

The two projects on which intervention was concentrated:

- *Since Deal* in Tigray: 58 cooperatives in urban area have become central to the awareness raising campaign in promotion of safe and dignified labour respecting all Covid precaution measure; more specifically all have received a kit including alcohol, gloves, masks and hand sanitizer in addition to *ad hoc* funding to face the crisis;
- With the project “ENJOY”, Swiss Caritas as lead organization, food, and individual protection devices/hygiene kits especially in favour of the young people mostly hit by the economic consequences of

the pandemic were distributed. Through the microenterprises of the territory 5.000 washable masks were produced and distributed to 800 recipients among unemployed youth, women, and internally displaced persons. For 400 of them, considered among the most vulnerable, the support also included food supply (flour, rice, oil). Furthermore, 10,000 surgical masks were provided to the local health units belonging to the two districts to support the health workers mostly exposed in the fight against the spread of the virus.

## VIS IN GAMBIA: MAIN INTERVENTIONS IMPLEMENTED

VIS is present in Gambia since April 2019 thanks to the project funded by the CEI “*Liberi di partire, liberi di restare (Free to leave, free to remain)*”. The presence of the activities promoted by VIS in Gambia is justified by the high percentage of migration from this country. Through a better and increased offer in TVET and access to the labour market the hope is to make Gambia more attractive for the young people and therefore contribute to fighting undocumented migration. During 2020 focus was centred on the implementation of the ongoing activities which have become more complex than what foreseen due to the general uncertainty situation linked to the pandemic and the turnover in the local project manager who ended his collaboration a few months after the beginning of the mandate. The health crisis has caused a general decrease of the activities for some months the TVET centres have remained closed, and the activities implemented from remote, with a lot of difficulties due to the lack of technological means and internet connection of the students. During 2020, therefore, there has not been the opportunity to proceed expanding in the country as foreseen.

## VIS IN GHANA: MAIN INTERVENTIONS IMPLEMENTED

Notwithstanding the negative conditions due to the pandemic, it has been possible to complete various project activities and implement a specific project for fighting the spread of Covid-19, through awareness raising activities via the radio.

Vocational training has remained the focus of the projects together the job placement for vulnerable youth, potential migrants and return migrants through the labour service offices and a development fund. The issue of undocumented migration remains today important in Ghana also considering the pandemic; in fact, some rights of migrants are seriously compromised such as the right to liberty of movement (art. 12 ICCPR). The collaboration with the *University of Ghana Business School* within a marketing course implemented for the project *LEEWYV* has been extremely interesting which has been the first step to start the production of black soap with 48 women association. This organic soap is widespread used in Ghana. More than 1.300 vulnerable women have been trained in the production of this biological soap and the marketing course has offered the possibility to set up an effective system for its management and production, while the training in organic agriculture have seen 103 vulnerable young people involved who have been able to learn these new techniques in the 10 educational farms set up by VIS. The innovative means utilized in the course is the *greenhouse* entirely built with the local materials and designed by the *Don Bosco Technical School* of Sunyani. However, the awareness raising campaign to fights undocumented migration could not be carried out as the schools and the youth centers were mostly shut down because of the anti-Covid-19 provisions ordered by the Ghanaian government.

Regarding the volunteers, VIS Ghana remains a very active *hub* for the building experience for volunteers and/or interns and for their future growth and eventual placement in VIS projects. This year, even if with the difficulties due to the pandemic, the civil service girls have continued to follow the projects once back in Italy for safety reasons.

## VIS IN MALI: MAIN INTERVENTIONS IMPLEMENTED

Notwithstanding the instability situation of the country, the present unsafety, and the dramatic occurrences of the year, in 2020 the expected results of the CEI project have been partially attained. The project continues to be managed directly by the ADAFO Salesian partner while the Salesian centers and Caritas take care of the implementation of field activities.

The research that has been implemented regarding the link between vocational training and migration has allowed to understand better the migration phenomenon in the areas of intervention and has confirmed the tight link existing between the lack of training opportunities and employment and migration.

The methodology applied is above all based on strengthening the local actors in the vocational training area and in job placement in synergy with the fight against undocumented migration as the target are young potential migrants and return migrants.

The motivation of VIS presence in the country remains strong due to the existing problems and hence the importance of interventions in the above-mentioned sectors (fight against undocumented migration, creation of opportunities for the most vulnerable in the rural areas, etc.), all within the program “*Stop Tratta*”. However, the operational and strategic framework is lacking for achieving new partnerships and projects, hence, to expand the mission.

## VIS IN NIGERIA: MAIN INTERVENTIONS IMPLEMENTED

VIS has started working in Nigeria together with the Salesians in 2018 with the aim of fighting the undocumented migration flow, an endemic problem in Nigeria, with the project “*Free to leave, free to remain*” funded by the CEI. In 2019 the project *UNO*, funded by the CEFA with funds of the Ministero degli Interni has been added to promote the socio-economic reintegration of voluntary return migrants in Nigeria and Senegal, for their permanent reintegration in society through the purchase of goods/services for their economic activities and/or support to their training. In November 2020 the *FAMI* project started with the aim of providing a basic training to regular migrants who have requested family reunification.

The year 2020 has been characterized by the COVID pandemic which has had a strong impact on the activities delaying them. For operative opportunity reasons it has been decided not to start the registration procedures in the country.

## VIS IN SENEGAL: MAIN INTERVENTIONS IMPLEMENTED

VIS action in Senegal is expanding. In 2020, besides the activities already ongoing since 2018, the AICS project Emergency in the region of Tambacounda and the *FAMI* project in favour of regular migration have been started. Thanks to the activities implemented it has been possible to promote with the Senegalese authorities actions in the areas of migration, vocational training and socio-labour placement for vulnerable youth and potential migrants. The interventions of the projects are in line with the “*Stop Tratta*” campaign and reflect a clear merging of intentions and actions in the field. The knowledge of the local context, of the political and institutional dynamics and of the same institutions has increased and this makes the relationship with the institutions quite fruitful. The start up of the Emergency AICS project has allowed a range of activities directly involving the young people of the area (scholarships and trainings). To provide an answer to the health crisis linked with Covid, CEI has funded an awareness raising and upgrading of the skills of medical staff and community agents project in the regions of Tambacounda, Kaolack, Thies and Dakar. In terms of planning VIS continues to operate in the migration and development areas as well as in the TVET and job placement

sectors. The issue of undocumented migration remains at the center of most of the strategies of partners and donors.

## VIS IN BOLIVIA: MAIN INTERVENTIONS IMPLEMENTED

During 2020, VIS continued intervening in Bolivia in child protection through two specific projects. The first, born out of the historical collaboration with the local Salesian Province is focused on supporting children and adolescents in street situation who are directed towards the Salesian shelter “*Tetto Pinardi*” in Santa Cruz de la Sierra, where they have been constantly accompanied within a targeted growth and social re-inclusion program. The second is framed within the project funded by UNICEF Bolivia based on the child right to live within a family. In this context the high-level training action has been strengthened in this respect for public officers and social operators of the Pluri-national child protection system of the regions of La Paz, Cochabamba, and Santa Cruz, through the continuation and conclusion of a masters and the establishment of three short courses in collaboration with the Salesian University of Bolivia. Furthermore, the family re-integration and/or definition of the legal situation of minors residing in the shelters Cochabamba and Santa Cruz have continued. Finally, due to the spread of Coronavirus in Bolivia, a set of actions have been implemented for the protection of the minors involved in the project. During 2020, VIS has carried out the intervention to support children with disability together with the local partner EPDB, within the three-year project co-funded by AICS, with the Fondazione Don Gnocchi as lead organization. In particular, the intervention was focused on concluding the refurbishing of the school buildings to knock down the existing architectural barriers and on continuing the training sessions for directors and teachers together with

awareness raising spaces for students and families in 4 schools near Cochabamba on school and social inclusion of children with disability or learning difficulties. In 2021 it is foreseen to complete this last project (the only one still ongoing) and proceed with closing VIS presence in the country.

### Interventions in response to Covid emergency:

From the end of March to the end of October 2020, in coordination with UNICEF Bolivia, VIS has implemented the following interventions in response to the emergency:

- Purchase and distribution of food packs to 40 vulnerable families involved in minors’ reintegration processes in the regions of Cochabamba and Santa Cruz;
- Purchase and distribution of food and medicines to 26 shelters (in which 528 minors are hosted) and individual safety devices to 10 public institutions in charge of child protection in the region of Santa Cruz.

## VIS IN EGYPT: MAIN INTERVENTIONS IMPLEMENTED

In 2020 two project initiatives have been evaluated positively by VIS. The continuation of the project *“Youth and labour in Egypt: for new training and professional inclusion opportunities”* received the approval in March with the title *“Youth employment promotion in Egypt through training, innovation and synergy with the market”* (Fondo di beneficenza Intesa S. Paolo). This initiative will allow to continue supporting the innovation process already initiated through the first project in support of two technical and vocational Salesian schools in Cairo and Alexandria. Moreover, the approval of the *FAMI* project (Min. Interno e Lavoro italiani) has allowed to open a new area in migration and development at the Salesian establishment in Cairo. The interventions have been started respectively in September and October 2020.

VIS role within the PDO, through the presence of its expat staff (coordinator and *focal point* for the abovementioned projects) has continued to provide support in attaining a development vision and upgrading the capability of project design and management. This has allowed to explore new opportunities for development and to define new project proposals both in continuation of the interventions already implemented in the training sector and in the migration sector. In addition, a strengthening process of the network of contacts with donors and partners (UNHCR, IECD, Caritas Alessandria) has been initiated.

As projects have been started at the end of the year 2020, results will be evidenced starting from next year.

## VIS IN PALESTINE: MAIN INTERVENTIONS IMPLEMENTED

VIS is present in Palestine since more than 30 years. During this long period which has been characterized by many changes in the political, social, economic and institutional scenarios, VIS has grown a lot. It has adjusted

its work to the changed needs of the Palestinian population, together with whom it has never stopped operating.

The sectors in which VIS presently is engaged are many: technical-vocational training and job start, socio-economic development, *capacity building* of local institutions. Projects are implemented together with different local partners, starting from the Salesians of Don Bosco first partner in the country, the University of Bethlehem, the local authorities, Italian and international NGOs, Italian Universities, and companies, etc.

This engagement started since more than ten years, characterized by three important three-year projects funded by the Italian cooperation and two by the EU in the territory of Malësi e Madhe, contributed to affirming VIS as important referral in rural development and confirmed its geographic grounding in the North of the country. Such width of action has confirmed and broadened the collaboration and role within the national and international *networks*. In addition, thanks to the present ongoing intervention, *Zana e Maleve – Youth and territory*, VIS is expanding its focus also to young people and the social sector and to the services for the communities.

2020 has moreover marked two new important confirmations in the environment protection, with 3 new projects focused on it and the consolidation of the relationship with Caritas Italia and Caritas Albania both in the start-up of a new project for young people in Klos, and in supporting the families hit by the earthquake of the end of November 2019.

- Implementation of *housing assistance* and recreation of the Bubq families hit by the earthquake.

In addition, the social section #ViaggioinAlbania was created with 80 visits to the news on the website and coverage of 10,333 on Facebook with 1,002 interactions.

The factors that hindered the effectiveness of the interventions are mainly the slow response capacity on behalf of the local LAs on operational issues, in particular the regularization of land ownership and the closure of universities due to Covid, which prevented the start of the course for local development agent.

- Distribution of food packs to more than 80 families in Malësi e Madhe;
- Distribution of anti-contagion devices to 301 beneficiaries.
- Petrol refuelling and logistical support to the local police during lockdown.

## OPERATIONAL CONTEXT

Italy was one of the first countries hit by the Covid-19 pandemic. Since the end of February to the beginning of October 2020 more than 300 thousand cases of contagion have been confirmed and 35.875 persons lost their lives. In addition to the seriousness of the health emergency, there are the consequences on an economic, social, and educational level that have generated a huge impact especially on the most vulnerable segments of the population. For this reason, the project *“The answer of VIS, the Salesiani per il Sociale Aps and CNOS FAP to the Covid-19 emergency in Italy”* was launched. Thanks to an integrated strategy, the project aims at reaching some of the most vulnerable and more hit by the consequences of the pandemic categories of people and at the same time to Foster the values of international cooperation, social cohesion, and the solidarity among the States, in particular the USA toward Italy. 24.480 are the direct beneficiaries of the project including teachers, students, families, young people, children, migrants, and refugees with interventions involving 16 Italian regions for 15 months.

The project foresaw different training activities aimed at supporting the period of distance learning that all Italian school had to deal with and provide means for reflection and analysis of the socio-health situation and its consequences above all for the young people. The activities planned – *web talks*, online courses, digital devices, an educational kit and a competition for the schools – have allowed students, teachers and families to face the difficult moment with innovative and original educational tools aimed at facilitating the contextualization and understanding of the complex situation lived in.

- 53.100 surgical masks, 12.170 FFP2 masks, 162.000 gloves and 19.400 litres of sanitizing gel have been distributed in 30 youth centers;
- the first reception service for migrants and refugees has been started in collaboration with the association Don Bosco 2000.

# GLOBAL CITIZENSHIP EDUCATION AND CAMPAIGNING

During 2020 VIS awareness raising and *campaigning* actions have been mainly concentrated on the campaign *resto@attivo*. The other planned campaigns, ongoing since years, due to the pandemic have been suspended or have undergone a strong delay. Among these *Territori diVini* (events wine-solidarity to raise awareness on VIS activities in Palestine or on other relevant projects), *No Wall in Palestine* (on the issue of occupation in Palestine and on the separation wall) and *Stop Tratta* (on non-discrimination and fight against trafficking in human beings issues) must be recalled.

The pandemic has not allowed any type of education initiative in the schools nor events in the territories. In 2020 a detailed and participated strategic planning however has been made to relaunch the coordination and the activities of VIS presidia on the national territory. Some of them have actively participated in *resto@ttivo* organizing *web talks* and *webinars*.

At strategic partnerships level related to the actions of this sector, a gradual strengthening of the *partnership* with some structures of the Salesian Family can be highlighted, more specifically with MDB and Don Bosco 2000. With MDB some coordinated fund raising campaigns have been implemented (Angola, Christmas), followed by – in November – the start-up of the process for designing the Tigray emergency campaign in Ethiopia. Together with Don Bosco 2000 two events have been held in Catania for awareness raising and launch of the brand “Beteyà”, a Sicilian *start up* specialized in textile production of garments and clothing accessories with the aim through an ambitious and responsible project to put forward social development and back lawfulness in the Sicilian territory. The events planned for 2020 together with Don Bosco 2000 had to be 5 but due to the pandemic it has been possible to organize only 2 in Catania, in which altogether around 300 persons participated.

## ***Un Mondo Possibile***

*Un Mondo Possibile* is VIS magazine, the communication, education and update means of all activities implemented by the organization. This is sent free in paper or digital form to more than 13 thousand subscribers. In 2020, different from the previous years, due to the operative slowdown caused by the pandemic, only 3 out of the foreseen 4 issues were published.

## ***Twinnings***

Twinnings foresee an exchange of different materials (messages, photos, documents, and videos) thanks to which teachers and students of North and South of the world can become acquainted with “different” realities and face topics such as intercultural education, based on a concrete experience. VIS facilitates such exchange between teachers and students offering a virtual space for this sharing within its own website [www.volint.it/vis/raccontiamoci](http://www.volint.it/vis/raccontiamoci). As what has happened for the activities on the territory implemented by VIS presidia, due to the international *lockdown* also twinning typical activities have undergone consistent delays compared to the previous years.

## SPECIALIST AND UNIVERSITY EDUCATION

Coherently with its scope related to the “promotion and organization of training and education initiatives and activities, connected with the promotion of volunteering, international cooperation and promotion and protection of human rights” VIS since several years has launched the Scuola di Alta Formazione (Higher Education School) offering online and in presence courses for young people and citizens interested in development cooperation and international volunteering.

The pandemic situation in 2020 has in different cases implied changes in the training planned activities. In particular it was decided to:

- Propose increased and diverse online training proposals during the *lockdown* to reach the audience on the net which due to the changed context has certainly increased and therefore satisfy the request, likewise increased, for trainings from remote;
- Implement and activities aimed at disseminating VIS activities which has allowed to reach a broader audience (about 80% of those enrolled in the courses are new) and therefore to have a net increase of enrolments per course.

In detail it was agreed to:

- Offer a larger number of editions of some course already planned (Administer development, Intercultural education);
- Reconvert online some course that had been designed to be held in presence (Administer development, Activities Summary Report, *Concept Note*);
- Offer free participation in *smart trainings* to all the staff on Headquarters and expats as internal training. The same participants have been involved also in the training;
- Propose free *web talks* with the aim of giving visibility to the Scuola di Alta Formazione and disseminate topics important for the public during the *lockdown* within the *resto@ttivo* campaign.

Regarding higher education, VIS has strengthened its role within the Cooperation and Development Network (CDN), contributing more strongly to the teaching of the Master of Pavia. The partnership with the Master of LUISS regarding teaching, offer, internship management and teaching strategic planning was also confirmed for the second year. With a view to increasing VIS presence within university institutions, the design and teaching of the course "International Cooperation for Development" was conducted at the Faculty of Social Sciences of the Pontifical University of San Tommaso D'Aquino.

Still in relation to training and education objectives, in 2020 - during the months of lockdown - through the *resto@ttivo* campaign, VIS offered various tools for the schools to deal with the new circumstances: a digital didactic kit to propose new ways of reading one's own internal relationship, between oneself and others (especially parental relationship) and between oneself and the surrounding reality, in particular the domestic environment. The kit allowed teachers to have an extra tool to deal with the new complicated pandemic situation and for students to be able to use it even in family relationships. At the end of the first national lockdown and after the summer break, in continuation with this campaign, VIS launched *resto@ttivo nel mondo*, a communication and fundraising campaign to support recovery and involvement of national public opinion in the project activities carried out in the partner countries.

# HUMAN RIGHTS & ADVOCACY

VIS implements advocacy actions directly and through networking with the aim of awareness raising and influencing the institutions that at various levels (national, European, and international) with their actions and decisions can impact on the following specific areas: quantity, quality and effectiveness of international cooperation and fight against poverty, promotion, and protection of the rights of children and quality of education.

Advocacy is carried out taking advantage of the cleavages offered to CSOs by the international systems (UN, Council of Europe, EU) to operate within the institutions to Foster and contribute to the political and social change at national and local levels. VIS, also to fulfil its commitment with its special consultative status ECOSOC with the United Nations, participates in conferences, fora, world summits, prepares supplementary reports to the UN Treaty with particular attention to the new mechanisms set up by the UN Human Rights Council including the UPR – *Universal Periodic Review*, the Agenda 2030 for sustainable development and the connected mechanisms, and the international campaigns.

## 3. ECONOMIC DIMENSION

---

In this chapter of the Activities Summary Report the most important elements that make up VIS income statement for the year 2020 are provided compared with the previous year. These data are excerpt from the 2020 final balance sheet reviewed by the auditing company BDO Italia, as well as by the Board of Auditors during the statutory activity provided for. Below is a synthetic overview of VIS Income Statement, with the list and the composition of the budget lines and the corresponding previous year values.

### 3.1 OVERALL FRAMEWORK

During the 2020 financial year, VIS recorded a total income of € 10.488.109, while in 2019 the total income was € 11.351.746, with a decrease of € 863.637; expenditures recorded a total of € 10.486.028, while in the previous year it was of € 11.349.502, a decrease of € 863.474. The result for the year 2020, equals € 2.081, in line with the one of the previous year equalling € 2.244. At the end of the year, the Association began an internal reorganization process, after having carried out an assessment of the critical issues that emerged from the application of the organizational model introduced at the end of 2016. This process, at the time of writing these Notes to the Accounts is still in progress, and the results of which will be brought to the attention of the Executive Committee by October 2021.



As emerges from the following graphic, income from private sources equal those from public funding for the year 2020.



Regarding the trend of the main institutional donors for the year 2020 the following can be highlighted:

- income from the AICS has confirmed an increase determined by the continuation of ongoing projects fostered in Albania, Senegal and Palestine, the implementation of emergency interventions and assigned *in loco*, e.g. ongoing projects in Ethiopia, Palestine, Albania and Senegal; in addition also the trend is confirmed concerning income from projects funded by AICS to partner project leader organizations, which are evidenced under budget line "Different private donors (foundations, partners, *network*, etc.)";
- income from the EC for the year 2020 have decreased because of the conclusion of some multi-year projects, while some interventions in Angola, Albania and Ghana are continuing; noteworthy is the approval by the EC donor of projects with a lead partner NGO in Ethiopia.
- the trend in decrease of income from governmental 5x1000, 8x1000 and international organizations and other cooperation agencies deriving from the conclusion of interventions implemented in Eritrea is confirmed; slightly increasing are funds provided by the territory entities (decentred cooperation);
- there are prospects of increase in funding for the following year in contributions from international organizations and other cooperation agencies, including national and international partners.

As per funds from private donors, in 2020 an absolute decrease in total income compared to the previous year is evidenced, mainly due to the drop in donations and contributions caused by the pandemic and its consequences on fundraising and on some donors. In particular, the decrease involved the budget lines "Other development projects and interventions", "Support for missionary activities" (SaM) and "Corporate fund-raising" (for which the project has been closed).

Also, the funds deriving from 8x1000 of the CEI, have decreased for the closure of various projects in Africa and Latin America; however, recently this donor has approved new interventions (in DRC and Angola) which will produce economic results in the following year.

It is highlighted that contributions received by public donors have all a specific destination and predefined obligations in terms of use and reporting. In the case of the major donors (e.g. AICS and EU), the procedures establish also that each report must undergo an *audit* carried out by third-party auditing companies for the purpose of greater transparency in the use of the funds received.
